Pool Rules Reminder – Ocean Village Main Pool

Ocean Village's Main Pool is a favorite gathering place for residents and guests to unwind, connect, and soak up the Florida sunshine. To ensure a safe and pleasant experience for everyone, we kindly ask that all visitors adhere to our posted pool rules. These guidelines are in place not only to promote courtesy and enjoyment but also to maintain compliance with Florida Health Department regulations.

Please pay great attention to the following important rules:

- **Rule 6**: Do not move furniture into the zero-entry pool area or place it on the pool edges.
- Rule 11: No food, snacks, or glass of any kind are allowed on the pool, kiddie pool, or spa decks, at the tables, or in either pool or the spa.
- Rule 12: Alcoholic beverages are permitted on the pool deck only if purchased from the Tiki Bar. No outside alcohol is allowed.
- **Rule 13**: Non-alcoholic beverages in non-glass containers may be brought from home and are permitted on the pool deck.
- **Rule 14**: All individuals who require the use of a diaper, regardless of age, must wear a swim diaper when using the pools or hot tub.

Our **Pool Monitor** is on duty to assist with enforcing these rules and to help ensure a safe and enjoyable environment for all. Your cooperation is greatly appreciated—thank you for doing your part! The complete set of pool rules is shown below.

OV Beach Club Pool, Spa, and Kiddie Pool Rules

- 1. Operating hours: 7:00 AM to Dusk. No swimming outside designated hours.
- 2. Visible Ocean Village wristbands required for all users over the age of 10.
- 3. Capacity: Pool 80 persons. Non-swimmers and children under 12 must be accompanied by responsible supervision.
- 4. Capacity: Spa 17 persons. Children under 12 must be accompanied by an adult. Children under the age of 5 are not permitted in the spa/hot tub due to elevated water temperatures which may pose health risks.
- 5. All lounge chairs and pool furniture must be covered with towels before use to avoid getting oils and suntan lotion on furniture. Gently close and secure umbrellas in high winds and when departing.
- 6. Do not move furniture into zero entry pool area or on pool edges.
- 7. Lounges, chairs, tables, umbrellas are used in a first come first serve basis and cannot be reserved. Only one lounge chair per person towels will be removed if vacant for one hour.
- 8. Proper swim attire required. No street clothes in the pool.
- 9. Shower before entering the pool, spa and kiddie pool.
- 10. No jumping, diving, running, ball playing, horse play or loud or disruptive behavior.
- 11. No food snacks or glass of any kind on pool, kiddie pool or spa decks, at the tables or in either pool or the spa.
- 12. Alcoholic beverages are permitted on the pool deck (must be purchased from the Tiki Bar). No outside alcohol may be brought to the pool and consumed.
- 13. Non-alcoholic beverages in non-glass containers can be brought from home and are permitted on the pool deck.
- 14. All individuals who require the use of a diaper, regardless of age, must wear a swim diaper when using the pools or hot tub.
- 15. Persons with open wounds, infections fungus and persons with contagious or unsanitary skin conditions cannot enter the pool, spa, or kiddie pool.
- 16. No smoking, vaping, or tobacco products may be used within the pool area, on the pool deck or at the pool tables, chairs or lounges.
- 17. Smoking is only allowed at the designated area at the Tiki Bar.
- 18. No floats, beach or other balls, surf or boogie boards, frisbees, or other toys or flotation devices are permitted unless used in conjunction with or activities pre-approved by management. Exceptions include Coast Guard approved personal flotation devices or arm floaties on small children or non-swimmer adults.
- 19. No skates, skateboards, bikes, strikes, hover-boards, or other wheeled apparatus except wheelchair or medically necessary devices.
- 20. No pets are allowed in the pool, pool area or Tiki Bar area. Only service animals as defined by Title II and Title III of the Americans with Disabilities Act are allowed in the pool area.
- 21. Pool may close during inclement weather (thunderstorms, lightning) or for maintenance.
- 22. No loud disturbing or excessive noise radio, phones or other sound amplifying devices may be used without headphones except when in conjunction with or activities pre-approved by management.
- 23. All trash must be disposed of in designated containers.
- 24. The POA reserves the right to suspend pool privileges for rule violations.

Florida Oceanographic Society - Live Fish Cam

One of my favorite places to visit and take my daughters and grandchildren to is the Florida Oceanographic Society Coastal Center in nearby Stuart. In addition to their numerous programs for all ages, they also have a live Fish Cam on their website! The cam is streaming Gamefish Lagoon, which is a 750,000-gallon saltwater aquarium. It is home to over 20 different fish species, including stingrays and nurse sharks. Go to https://floridaocean.org and simply click on the "Fish Cam" link.

After checking the live Fish Cam, plan a visit to the 57-acre Florida Oceanographic Center nestled between the Indian River and the Atlantic Ocean. The Center serves as a beacon of environmental awareness and education, research, monitoring, and restoring habitats in South Florida, especially in the Indian River Lagoon.

A key component of their program is the involvement of the community in their efforts. They coordinate several programs in which volunteers are directly involved in research and data collection. This information is then disseminated directly to our local community. It is their hope that these citizen scientist programs foster not only knowledge, but stewardship of our treasured Florida ecosystem. Please consider volunteering at the Center. 

Feeling Artsy?



You are probably familiar with the beautiful Crain House, now the Peacock House, on Orange Avenue in downtown Fort Pierce. According to TC Palm's Crystal Vander Weit, the peacocks and peahens are a legacy of Jack and Mary Lee Crain.

According to his obituary at Legacy.com, Jackson Crain was born in East St. Louis, Illinois, and was a longtime resident of

Fort Pierce. Jack attended school in St. Louis before serving in the United States Army. After being discharged, he went to work for the railroad in Missouri. While in Missouri, Jack met Mary Lee Steinhoff, who lived next door to his aunt. He married her February 9, 1952, and they moved to Orange Avenue in Fort Pierce. Jack opened Buccaneer Building & Tile Company and American Travel Agency, which he operated along with his wife, Mary Lee, for 29 years. He also served as a Scout Master for the Boy Scouts of America.

Jack was a member of St. Anastasia Catholic Church, and had an affinity for peacocks and peahens, which he raised at his home on Orange Avenue. He also enjoyed coin collecting, traveling, and collecting knives, swords, fine art, and paintings from around the world. Jack and Mary Lee traveled around the world nine times. Jack passed away at his home on October 17, 2016. He was 90 years old. Mary Lee died in 2019.

The Crain House is now the home of The Peacock House Art Foundation. Founded in 2022, it is a not for profit organization with a charitable purpose:

- To further develop and support the Peacock Arts District of Fort Pierce and our local art community through public art exposure and art education
- To provide artists with resources, tools, exhibit opportunities and an Artist-in-Residence Program
- To bring diverse multicultural and international artists from around the world, including Miami, New York, Stockholm, Orebro, and more...
- To connect the community to welcoming and safe venues for the exploration and practice of the arts, community building and inclusion, and artistic growth and development in the city of Fort Pierce

The Foundation offers tours of the Crain estate every Monday, Wednesday, and Friday at 11 AM, and they also offer classes for both kids and adults:

• Visible wristbands for play.


We encourage the use of quieter 14-16 mm carbon fiber-faced paddles.

OCEAN VILLAGE PICKLEBALL

COURT RULES:

- 1. Absolutely no play or practice before 8 AM
- 2. Proper attire, including shirts and court shoes, is required at all times.
- 3. Courts are for pickleball use only. Unauthorized activities such as bicycles, rollerblades, skates, or skateboards are not permitted
- 4. Open play drop-in times, league play and special events scheduled by the Recreation Department have priority.
- 5. No music, food, or glass containers permitted on the courts.
- 6. Do not use courts when wet.
- 7. Pets are not allowed on the courts.
- 8. Smoking is prohibited on the patio, walkways, and courts.
- 9. OV wristband required at all times.
- 10. Please keep voices and noise at a respectful level to ensure an enjoyable experience for all.
- 11. To maintain a peaceful environment, the use of the loudest paddle types such as wooden of 1/2 thick fiberglass or graphite faced paddles are prohibited. We encourage the use of quieter 14-16mm carbon fiber-faced paddles for an improved playing experience for all. Rental paddles are available through the Recreation Department.
- 12. Reservations can be made same day or up to five (5) days in advance online at oceanvillage.com, by telephone at 772-429-7415 or at the Recreation office.

Setting up the Blue Stream Smart Home App allows you to manage your home network. See below for a few short steps to get you set up.

STEP 1

Once you have downloaded the app, click on the Blue Stream Smart Home App. It should look like this.



STEP 2

Select "Sign Up" towards the bottom of the screen.



STEP 3

Enter Personal Information. The password you enter here will be used to access the app.



STEP 4

If your system is plugged in, select "Yes" to continue. Then, scan the QR code from the sticker included in the Calix ONT box or select "Issues Scanning" to enter MAC addess and serial number manually.

Why Some FL Beaches May Be Vanishing Due To Climate Change And Sea Walls

As sea levels rise, should property owners in FL be allowed to build sea walls, which inhibits beaches around them?

Once upon a time, beaches had a natural defense against rising seas. The sand moved landward. Since then, natural ocean rhythms have sped up.

Now researchers conclude that sea level rise is expected to cause chronic shoreline retreat, affecting over 10% of the world's population in low-elevation coastal zones. As a result, coastal landscape management is taking many different routes. Local communities are doing all they can to ensure the protection of people and buildings from storm waves that come crashing to shore.

Rubble mound sea walls are often constructed along coastlines to protect inland areas and infrastructure from wave attacks and coastal flooding.

Geospatial datasets derived from satellite imagery show that 33% of the world's sandy coastline is currently hardened by structures like sea walls.

Yet when sea walls are erected to protect beachfront homes and buildings, the beach vanishes. The dynamics of coastal geology are complex. Passive erosion occurs when rising waters meet unmoving barriers like sea walls. When one portion of a beach is built up this way, water often seeks its way around the barriers to pummel the beach down the way.

In the sixth century, Roman Emperor Justinian stipulated that the shorelines were open to all. Under this legal concept of common property, the tide and submerged lands were unique. No one could hold private ownership over the air, rivers, sea, and the seashore. These shoreline features were for public use, and the state was to hold them "in trust" for the people.

That idea passed into English common law and then to the US. Today most states define the beach below the high tide line as public trust property, meaning members of the public have free access. Florida statutes, for example, describe that "the land to which the owner holds title must extend to the ordinary high watermark of the navigable water in order that riparian rights may attach."

In Justinian's time, global sea levels had been generally stable for at least 2,000 years. They remained that way until the 20th century, when humans started changing the planet's climate. Climate change is not just an environmental issue — "it's a risk multiplier," analyzes author Weston Wilson in the newsletter, We Don't Have Time. Indeed, coastal geologists predict at least three feet of sea level rise in this century.

Sea level rise is already impacting widely different locations like Miami, the Netherlands, Bangladesh, and the island states of the South Pacific. Each location requires a separate and regionally-appropriate adaptive response.

Most of the world's sandy beaches are "likely to face severe beach loss" by 2100, the authors of a study in Nature concluded. Projects to replenish eroded beaches with pumped-in sand help to ward off the effects of rising seas. Costs are projected to increase with sea level rise and with more frequent and more severe storms triggered by climate change.

Why Dunes Protect Coastal Communities Better than Sea Walls

Ultimately, when an ecosystem is either preserved, sustainably managed, or restored to provide benefits to society and to nature, positive results occur. Nature-based solutions have been proven to be a consistent, cost-effective approach to mitigate environmental hazards, including sea level rise.

Underappreciated nature-based solutions for sea level rise are dune systems like the one at Ocean Village. Sand dunes are naturally occurring dynamic coastal features which are formed by the accumulation of wind blown sand. They are the first line of defense against ocean storms and act as a buffer to protect upland property and natural habitats.

The OV coastal dunes are a highly valuable multifunctional ecosystem that occupy a unique natural niche on South Hutchinson Island.

Supported by natural coastal geomorphic processes, these coastal sand dunes provide an array of important benefits. The presence of a well-established OV dune system, beginning with immature plants in the late 1970s and expanding in size in 2005, has acted as a barrier against storm waves. Thus, the dune system has helped to protect infrastructure located landward.

They provide a flexible barrier to the movement of high tides and waves, reducing erosion. Dunes can make the difference in shoreline protection of coastal communities, as the mature dune creates a habitat for aeolian transported sentiment — the movement and weathering of sand. A transverse short normal section shows that the OV installed dune grasses have captured windblown sand in several shore parallel ridges to create an elevated foredune with an undulating backdune swale.

The OV management plans of our coastal dunes

embrace the maintenance and planting of the natural vegetation, conservation of wildlife, control of visitors, the zonation of activities, and provision of amenities. It has been important to bear in mind that species richness and habitat diversity, which by their nature are highly dynamic, are greatest when a full sequence of successional stages is represented. The status of the OV dune vegetation varies section to section, and the individual Crossover sections have been monitored diligently.

Indeed, the OV coastal dunes provide direct and indirect economic benefits to the OV owners, their families, and guests. This is due to their location-specific ecosystem, which sits in relative proximity to the 1200 OV condominiums or single family homes. For this reason, as well as the unique coastal ecosystem that it provides, the OV dunes are a protected and precious environment.

That precious OV dune system, of course, has required ongoing and intensive coastal zone management. This has been needed to plan and control the complex interactions between the OV dune as a coastal resource system and its potential uses and users in systematic and sustainable ways.

The OV Beach and Dune Committee will embark on a project in autumn 2025 to add more plants to continue to support the dune system, especially after eradication of invasive wedelia over the past two years. OV owners are encouraged to donate funds to the upcoming dune plantings. In that way, owners can demonstrate pride in the protection of the most important amenity at Ocean Village.



The Architectural Board of Review

The mission of the Architectural Board of Review is to preserve the look and feel of Ocean Village for the benefit of all owners. If your cluster has all Cape Cod blue doors like Catamaran II, the ABR is there to say no to Cat II owners who want to paint their doors black in honor of the Rolling Stones.

Because of the work the ABR does, when your family members and guests visit, they see a community where all the buildings in a cluster are in harmony with each other.

ABR meets at 1 PM on the second Monday of every month in Aruba West. Owners are welcome to attend. Applications filed with the Admin office by the Wednesday before the meeting will be considered and acted upon that day.

All applications must be signed by the owners and approved by the Cluster president. The ABR relies on our cluster presidents to make certain the work to be performed meets all applicable building standards. There's a reason for that, one that became evident recently.

Capstan is facing a major concrete restoration project. Some of the damage may be attributable to windows and sliding glass doors that were installed incorrectly, which allowed water intrusion. Adhering to current building standards can minimize such issues.

The Capstan project was a challenge for ABR. Because the damage is so widespread, treating each unit on a case-by-case basis risked delaying repairs and increasing costs to owners. Thanks to the diligence of Barbara Russell, the Capstan owner in charge of the repair project, and the capable assistance of Dominique Harrison, our Assistant General Manager, the ABR was able to craft a policy that meets the needs of all Capstan owners while assuring the work will be done correctly with all necessary documentation provided to Admin.

In another recent instance, an owner in OV III was able to secure approval for a replacement sliding patio door within a day. OV III also is in the middle of an extensive concrete repair project. For this owner, the work required altering the size of the opening to the lanai so the existing slider could no longer be used. Once again, the members of the ABR committee were able to respond quickly so the replacement door could be installed immediately while the concrete restoration company was working on that unit.

When our General Manager, Holly Partington, came to Ocean Village, she brought with her a computer program that allows applications for ABR approval to be viewed remotely by members of the committee. This means the average time between submitting an application and getting a decision by the committee is now less than three weeks. ABR applications are available from your cluster president, the Admin office, or on the ABR page of the Ocean Village website.

Your ABR is working hard to preserve the look and feel of Ocean Village, while protecting the interests of all owners. If you are interested in becoming a member of the committee, please let Holly or Dominique know.
