

## **RULES FOR BEACHCLUB POOL, SPA AND CHILDREN'S POOL**

1. NO LIFEGUARDS ON DUTY — SWIM AT YOUR OWN RISK
2. Operating hours: 7:00 AM until dusk. Swimming outside of designated hours is not permitted.
3. Ocean Village visible wristbands are required for all users over the age of 10.
4. Capacity: Swimming pool — 80 people. Children under 12 years of age and people who do not know how to swim must be accompanied by a responsible adult.
5. Capacity: Spa — 17 people. Children under 12 years of age must be supervised by an adult. Children under 5 years old are not allowed.
6. Avoid oils or suntan lotion from coming into contact with furniture. Cover chairs and loungers with towels during use. Close and gently secure the umbrellas in case of strong wind and when retreating.
7. **DO NOT** move furniture or place it in the gradual entry area of the pool or on the edges of the pool.
8. Sun loungers, chairs, tables, and umbrellas are used on a first-come, first-served basis. They cannot be booked. Only one sun lounger is allowed per person. Towels will be removed if they are unattended for more than an hour.
9. Appropriate swimming attire is required. Street clothes are not allowed in the pool.
10. Shower before entering the pool, spa, or wading pool.
11. Jumping, diving, running, playing with balls, rough play or noisy or disruptive behavior is prohibited.
12. No food, snacks, or glass containers are allowed on pool, paddling pool, or spa decks, or on tables, or inside the pool or spa.
13. Alcoholic beverages are allowed on the pool deck (must be purchased at the tiki bar). Alcohol from outside is not allowed.
14. Non-alcoholic beverages are allowed in non-glass containers and can be brought from home.
15. All people who need to wear a diaper, regardless of age, must wear a swimming diaper when using the pools or hot tub.

16. People with open wounds, infections, fungus, or contagious or unsanitary skin conditions are not allowed to enter the pool, spa, or wading pool.
17. Smoking, vaping, or using tobacco products is not allowed inside the pool area, on the deck, or on tables, chairs, or loungers.
18. Smoking is only allowed in the designated area next to the Tiki Bar.
19. Floats, beach balls or other balls, boogie boards, frisbees, or other toys or flotation devices are not permitted unless used as part of activities previously approved by management.  
**Exceptions:** Coast Guard-approved personal flotation devices or arm floats for young children or adults who cannot swim.
20. Roller skates, skateboards, bicycles, tricycles, hoverboards, or other wheeled devices are not permitted, except for wheelchairs or other necessary medical devices.
21. Pets are not allowed in the pool, pool area, or Tiki Bar area. Only service animals as defined in Titles II and III of the Americans with Disabilities Act (ADA) are allowed.
22. The pool may be closed during bad weather (thunderstorms, lightning) or for maintenance.
23. Radios, telephones, or other sound devices that produce loud, annoying, or excessive noise are not permitted unless used with hearing aids or as part of activities previously approved by management.
24. All trash should be placed in designated receptacles.
25. Ocean Village POA reserves the right to suspend pool use privileges for violations of the rules.
