#### **Beach and Dune Committee:**

Carolyn Fortuna, our Beach & Dune Committee Chair reports the following:

### Fort Pierce Shore Protection advocacy project

Florida's beaches serve many purposes: storm protection, habitat, recreation, tourism, revenue, taxes, and a way of life. At the recent Florida Shore and Beach Preservation Association annual conference, we learned that it's not only Fort Pierce that is concerned about protecting, restoring, and managing our beach -- half of Florida's sandy beaches are critically eroding.

Among the responsibilities of the Beach and Dune Committee is "to initiate and sponsor political action activities, including petitions, letter writing campaigns and phone and email blasts on behalf of projects that will benefit Ocean Village." As part of that mandate, the Beach and Dune Committee has been working on a Fort Pierce Shore Protection advocacy plan.

In essence, the issue is to promote federal and local funding for the Fort Pierce Shore Protection Project and subsequent Study. It needs funding from several sources. The majority of project funds are those derived from the Water Resources Development Act (WRDA). That's the US congressional commitment to US water infrastructure. It authorizes studies and project construction and gives regular consideration of locally driven, rigorously studied, and nationally-significant water infrastructure. The 2020 WRDA has passed the House and is awaiting Senate action.

We've written sample letters about the WRDA which includes the Fort Pierce Shore Protection Project. We also have put together a list of contact information if you're a Florida resident. If you'd like to get a

Remember, as we are still in the social distancing mode, seating is limited. How about us having an ugliest face mask contest. No on will know who we are.


#### **Fall Bocce**
